15. Multidisciplinary / interdisciplinary

The primary goal of Avvaiyar Govt. College for Women is to equip girls students with a broader intellectual experience beyond their disciplinary boundaries in aligning with National Education Policy 2020. The policy promotes multidisciplinary approach to learning, empowering students with a unique opportunity to explore courses from various fields beyond their primary area of study. The college organised meetings with all staff members to orient and make them familiarize the policies of NEP. As an affiliated college, the college follows the curriculum prescribed by Pondicherry University. It has a holistic multidisciplinary curriculum that offers core and allied subjects. It offers Under Graduate Programme in the fields of Arts, Science, and Languages. Subjects like Tamil, English, and Hindi. French, Environmental Science and Public Administration were taught for first two semesters. Credit based course on Environmental Science and Public Administration as a part of multidisciplinary curriculum is also being followed. The College also emphasizes the adoption of a comprehensive and interdisciplinary approach to integrate and deliver the curriculum. This enables the students to learn different topics and subjects. The College motivates Students' participation in various extracurricular activities like NSS, RED Ribbon Club, Rotract Club, Fine Arts Committee, Ek Bharat Shrestha Bharat, Meri- Life Mission and Leo- Club etc.

16. Academic bank of credits (ABC):

The Academic Bank of Credit is a transformative concept that aims to provide students with more flexibility in their education. It operates on a credit-based system, allowing students to accumulate academic credits that can be transferred and recognized by various educational institutions. This innovative approach empowers students and assists institutions in meeting the evolving quality standards set by NAAC. Academic Bank of Credit (ABC) allows students to choose courses from different institutions, fostering a dynamic learning experience. The credit system enables the seamless transfer of credits earned by students. Our college has made it mandatory for students to register for the Academic Bank of Credit (ABC) portal from this year. Hence all our students have successfully enrolled and got ABC ID.

17. Skill development:

Skill development is the process of acquiring and enhancing the skills, knowledge, competencies, and abilities necessary to perform specific tasks or functions effectively. It is a critical aspect of personal and professional growth, education, and workforce preparation. Our College aligned with the National Education Policy, College has been proactively involved in enhancing students' skill sets through workshops, and certificate programs, enriching the curriculum, and offering diverse electives. Business Day is being organized every year by the Department of Commerce and ASCOMS (Association of Commerce Students) with the aim of developing entrepreneurial skills and to provide opportunity to study the subjects like marketing, accounting in a practical way. This helps the students to get experience in leadership and teamwork. Placement Cell in association with TCS Noida and Co -Organised by SC/ST, Pondicherry, conducted " Youth Employability Training program for SC/ST Students".

AGCW plays a crucial role in the integration of the Indian knowledge system into modern education. Here are some of the essential roles that colleges play in this integration. N.S.S unit of our College organized yoga session on 'International Yoga Day'. Besides, our students also celebrate Independence Day, Saraswati Pooja, and Pongal Celebrations with due reverence. One Day National Workshop on Vedic Mathematics was organized by the Department of Mathematics.

AGCW College bases its education on student outcomes. Learning Outcome-based Curriculum Framework (LOCF) courses offer students a great deal of opportunity to develop in terms of analytical abilities, creative thinking, and problem-solving skills. Several strategies are used to guarantee outcome-based education, including interactive classrooms, the use of IT resources like PowerPoint presentations, prompt distribution of books, and advice on how to get ready for exams. Additionally, there are a lot of student events held at the institution all year long, including extracurricular and cocurricular pursuits run by student organisations and departmental organisations. College Library has a treasure trove of 37908 books, 3028 Book Bank books and 2323 Reference books. Our college provides access of books and Journals to Students and faculties from NLIST Resources.

20.Distance education/online education:

The institution provides ample flexibility to the students to learn and explore through ICT- teaching is made possible by Wi-Fi enabled departments, smart classrooms, and well-stocked computer labs. The faculty was trained intensively to adapt to the changing scenario. The students were encouraged to interact in virtual classrooms. The use of technologies like LCD Projectors, Smart classrooms, and Language Lab has made online education quite efficient. During the pandemic most of the classes were conducted in the online mode. The faculty responded to the difficulties of the threat to education posed by the pandemic and changed the instructional approach. Online education was quite effective as it provided a better platform to share knowledge, notes, and power point presentations.
