15.Multidisciplinary / interdisciplinary

The institution is established with a vision to enable prosperity by providing quality education in to the rural masses who contribute to the process of national development. It also imparts undergraduate degrees in the streams of Humanities, Commerce and Science. Since it is an affiliated college, it follows curriculum of Pondicherry University. The college has implemented NEP Curriculum. At present, there are some courses which are interdisciplinary in nature. University has introduced Environment Studies, Understanding India, Health & Well - Being, Digital technology. The Faculty of Science is offering the following interdisciplinary courses. Interdisciplinary courses integrate concepts and knowledge from different scientific disciplines providing a more holistic view of a particular topic. Several exciting courses with elements of biology, chemistry, Zoology, Mathematics and Physics are currently available. Institute is a multidisciplinary in nature and there is scope to engage faculty and students to carry out multidisciplinary and interdisciplinary research to study the issues of local community. By encouraging multidisciplinary and interdisciplinary study, AGCW fosters multiplicity of perspectives.

16.Academic bank of credits (ABC):

Academic Bank of Credit (ABC) allows students to choose courses from different institutions, fostering a dynamic learning experience. In our college the Academic Bank of Credit has been implemented and nearly 800 students have successfully enrolled and got ABC Id. Since the institute is affiliated to university, it will follow the rules and regulations of university regarding transfer of credits. Credits will be awarded to the students after completion of the course and on clearing exams. This innovative approach empowers students and assists institutions in meeting the evolving quality standards set by NAAC. Also it improves transparency and flexibility in curriculum design. It enables the students to learn at their own pace and best courses of their interest. It also promotes student -centric education as it helps the students to rejoin the course in same or any other institute in the future.

17.Skill development:

The institution's takes much care in imparting skill development efforts through its enrichment of curriculum. Department of Maths conducted a "Seminar on Exploring Mathematical Horizons" on 2nd November 2023. IQAC. Department of Commerce and ASCOMS (Association of Commerce Students) with the aim of developing entrepreneurial skills and to provide opportunity to study the subjects like marketing, accounting in a practical way on 8th May 2024. Department of English conducted a workshop on Neuro Linguistic Programming (NLP) on 22nd March 2024. Placement Drive was organized for B.Com, BCS and B. SC (Computer Science) students on January 2024 at Women's Engineering College, Lawspet, Puducherry. 61 Students were selected and 34 have received offer letters.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Our students are learning credit based courses like Environmental Science, Health and Well-being, Understanding India to instil our Indian culture. The institution plays a crucial role in the integration of the Indian knowledge system into modern education. N.S.S unit of our college organized yoga session on 'International Yoga Day'. Besides, our students also celebrate Independence Day, Saraswati Pooja, and Pongal Celebrations with due reverence. During Cultural events, students are encouraged to put on traditional costumes and perform some traditional folk songs etc. Students also celebrate various festivals as part of Indian Culture. The Fine Arts Committee plans various cultural events to help the students to impart the importance of culture through fun. As a part of university syllabi, it offers mandatory courses like Modern Indian languages (MIL) apart from regular core subjects and Skill Enhancement Courses to the students to earn extra credits. The students are also given exposure about the Indian knowledge system through participation in culturally important places of India.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The focus of Outcome Based Education includes knowledge, skills, attitudes, evaluation of outcomes of the program. A graduate is expected to attain upon completion of a programme. In OBE, the educational outcomes are clearly and definitely specified. It determines the curriculum content and its organization, courses offered, teaching methods and strategies and the assessment processes. Our College takes much care on student outcomes. OBE offers students a great deal of opportunity to develop in terms of analytical abilities, creative thinking, and problem-solving skills. Several strategies are used to guarantee outcome-based education, including interactive classrooms, the use of IT resources like

PowerPoint presentations, prompt distribution of books, and advice on how to get ready for exams. Additionally, there are a lot of student events held at the institution all year long, including extracurricular activities. College Library has a treasure trove of 37908 books, 3028 Book Bank books and 2323 Reference books. Our college provides access of books and Journals to Students and faculties from NLIST Resources.

20.Distance education/online education:

The institution is affiliated to a University and therefore cannot offer vocational courses through ODL mode. The College has adequate IT infrastructure facilities. The institution provides ample flexibility to the students to learn and explore through ICTteaching which in turn is made possible by Wi-Fi enabled departments, smart classrooms, and well-stocked computer labs. The faculty was trained intensively to adapt to the changing scenario. The teachers of the institution are trained in the use of technology for teaching and learning. The teachers use blogs, Google groups, Google sites, Whatsapp and Google classrooms to communicate and share resources with students. The teachers use a wide range of technological tools and apps to make the classes stimulating and engaging. The students are also trained in the use of ICT resources. The use of technologies like LCD Projectors, Smart classrooms, and Language Lab has made online education quite efficient. Online education was quite effective as it provided a better platform to share knowledge, notes, and power point presentations.
